Harbor Freight Tools Inside Track Club Program Terms

By enrolling in the Inside Track Club ("Program"), you agree to (i) these Program Terms, (ii) Harbor Freight's general <u>Terms and Conditions</u> including, but not limited to, the Choice of Law, Jurisdiction, Dispute Resolution, and Class-Action Waiver provisions, (iii) Harbor Freight's <u>Return Policy</u>, and (iv) Harbor Freight's <u>Security and Privacy Policy</u> (collectively, the "Program Terms"), as well as to the decisions of Harbor Freight Tools USA, Inc. ("Harbor Freight") with respect to the Program, which are final and binding in all respects.

ELIGIBILITY: Membership in the Program is open to legal U.S. residents who are 18 years of age or older. MEMBERSHIP FEE AND MEMBERSHIP TERM: The current "Membership Fee", exclusive of all applicable taxes, is applicable for either a one (1) year or two (2) year period beginning on the date of initial purchase (i.e., enrollment) and ending on the day prior to the anniversary or second anniversary thereof, as applicable ("Membership Term"). The amount of the then-current Membership Fee will be posted in-store and online at harborfreight.com.

HOW TO ENROLL: You may enroll in the Program by purchasing a Membership in-store at the register, or online at harborfreight.com. In order to enroll in the Program, you must provide, at a minimum, your name and a valid email address and phone number. The full version of the Program Terms will be available in store upon request at or near the cash register and at harborfreight.com. You will receive a welcome email within seven (7) days following your initial enrollment, which will include a hyperlink to the full Program Terms.

END OF MEMBERSHIP TERM: Your Membership will immediately expire at the end of your Membership Term. In order to renew/reactivate your Membership, you must re-enroll in the Program by purchasing a new Membership in-store or online

MEMBERSHIP BENEFITS: As part of the Membership, Harbor Freight may, from time to time and in its sole and absolute discretion, offer certain "Benefits" to Members, which will be communicated to Members from time to time via email, online at harborfreight.com, and/or in-store postings.

<u>In-store</u>: You can access Benefits in-store by providing the Harbor Freight associate with the phone number and/or email address associated with your Membership at the time of checkout. In the event of any conflict between this Section and Harbor Freight's Return Policy, the Return Policy shall prevail.

GENERAL CONDITIONS: Program is subject to all applicable federal, state, and local laws and regulations, and the Program and/or any Benefits are void where prohibited by law. Unless otherwise specified by Harbor Freight, Program is not valid in combination with any other programs, specials, sales, coupons, promotions, or other benefits offered by Harbor Freight.
